## Old Business:

1. Discussion on board positions, roles and responsibilities. Carmen submitted in writing a resignation as Vice President and requested to be moved to a director position. Resignation was accepted. Pat nominated Breanne as Vice President, David second, all in favor. Breanne accepted the role.
2. Correspondence:
a. Matt Hogan submitted a projected profit and lost to show the possible benefits of joining together to put on events.
b. Bobbi read feedback provided by members, discussion surrounding positive, negative and new suggestions moving forward for the new season. All information is being considered in our planning process today.

## New Business:

1. Direction of Association:
a. Sponsored (CTPA Produced) Vs. Sanctioned (Promoter Produced): After a long discussion going over the Pros and Cons of both, we have decided to produce a few events and partner with a couple sanctioned events.
b. Floyd proposed we only put on 3 Man Sorting events, discussion concluded that for the 2023 season this would be the best option to save money on cattle costs, class structure, beginner friendly, set up and be easy to partners with other events since most are doing this format.

## 2. Event Structure:

a. Top 10 in every class
b. 5 points will be given to each participant per event for attendance.
c. Finals will continue to be named John Ludwig Memorial Finals
d. Added money for finals.
e. Announcer to introduce by name and hometown of open riders and top 10 riders. Intent is to entice lower riders to improve by introducing them to upper riders and acknowledge those riders that are putting in great effort.
f. To be able to compete for prizes at the finals, riders must attend 4 events + finals
g. All compliant Open Final winners will win a saddle (must attend 4 events + finals).
h. Point system - Donna made a motion to return to the original software points system that was created for our club, plus Donna will hand input 5 points per person per day. Breanne second, all in favor.
i. Buckles for class winners - Kasia will order all buckles for the year.
j. Discussed possible fee for late sign up.

h. If Skyhawk falls through, we will pursue partnering with Cascade Cattle Club on March $11^{\text {th }}$ at Brasada.

i. Tracie to contact Shiloh Ranch to confirm event dates and amenities - stalls, PA system, overnight RV, equipment.
4. Cattle:
a. Pat reports cattle costs should remain reasonable at $\$ 45$ for one day or $\$ 55$ for two days - cost includes feed

## 5. Classes \& Pricing

a. Classes as Follows: Open, 14, 9, 6 and Youth
b. Handicap on the 14,9 and 6 classes
c. $50 \%$ payback on $2^{\text {nd }}$ go and then top ten winners
d. Class entry pricing and payback
i. Open Class - $\$ 70$ entry and $60 \%$ payback
ii. 14 Class - $\$ 60$ entry and $55 \%$ payback
iii. 9 Class - $\$ 60$ entry and 55\% payback
iv. 6 Class - $\$ 50$ entry and $50 \%$ payback
v. Youth Class - $\$ 10$ entry and $80 \%$ payback
e. Shoot Out Class on Sunday
i. $\$ 150$ entry with max of 4 entries
ii. 75\% payback
iii. No Handicap
iv. Open to all ratings
v. Pick teams only
vi. No points
6. Rules:
a. David has noted that we need to enforce the following rules in Team Penning:
i. The only time you do not raise a hand to call time is when you have three clean cows in the pen. Time is call when the root of their tail crossed the gate.
ii. One hand must be raised to stop time when there is less than three clean cows.
